PROJECT MATTONE INTERNAZIONALE: THE THIRD MODULE OF THE NATIONAL TRAINING PLAN STARTING IN 2013

The Project MI continues to implement training activities at national level aimed at promoting cultural uniformity among the Italian regions on topics related to health systems.

Thanks to the input provided by participants at the modules n.1 and n.2, the module n.3 will be implemented in 2013 (probably in February and March). The residential training will consist of two courses: a) Drafting a project proposal and budget and b) Project management.

The training courses will include plenary sessions on working tools, specific activities and working groups, supported by experts, as well as in-depth studies of new EU programming 2014-2020.

Both courses will be implemented. The number of events and the composition of the participants involved will be scheduled based on a geographical criteria in order to strengthen the cooperation among regions. They will be defined according to the suggestions of participants above mentioned and in agreement with the regional representatives of the Project MI.

OUTCOME OF THE EVENT "ROLE OF THE REGIONS IN THE FUTURE OF THE EUROPEAN PARTNERSHIP ON ACTIVE AND HEALTHY AGEING"

On the 30th of November, the event entitled: "Role of the Regions in the future of the European Partnership on Active and Healthy Ageing" was held at the Ministry of Health. The event was very important for sharing experiences among the Italian Regions.

Following a welcome speech held by dr. Ruocco from the Ministry of Health, dr. Stocco from the Local Health Unit n. 10 of the Veneto Region opened the morning session presenting Italian Regions' project proposals on Ageing. Proposals were illustrated through the exhibition of project posters.

Later dr. Zagordo from the EC DG Sanco introduced future perspectives of the European Innovation Partnership on Active and Healthy Ageing and dr. Margetidis from the EAHC presented Lessons from the evaluation of the 2012 Call for proposals for projects submitted under EIP-AHA priority.

Subsequently, Prof. Pecorelli illustrated the role of Italy in pilot and A1 initiatives and dr. Marjan Sedmak, President of the Age Platform presented initiatives and findings within the framework of the 2012 European Year for Active Ageing and Solidarity between generations.

European Networks Coral and Euregha then presented their commitments and role within the action groups organized by the Commission.

During the afternoon session, the first round table discussion was moderated by dr. Antoni Dedeu from Euregha. Activities and outcomes of the Italian action groups involved in the EIP-AHA were illustrated by Emilia Romagna Region, Friuli Venezia Giulia Region, Piedmont Region, Campania and Apulia Regions.

The event closed with a second round table among Reference Site nominated by the EU in the EIP-AHA involving the following Italian regions: Piedmont, Emilia Romagna, Campania, Autonomous Province of Trento and Liguria.

The need for the organization of further meetings on the issue emerged as a result of the event. Additional meetings will allow an in depth analysis and contribute to the sharing of experiences among the Italian Regions.

OPEN CALL FOR PROPOSALS / TENDER

LIFELONG LEARNING PROGRAME(LLP) - CALL FOR PROPOSALS 2013 **EAC/S07/12**

8/9/22/23/29 November 2012 Last August has been published the general call for proposals 2013 of Lifelong Learning Programme (LLP). Every year, the European Commission defines the priorities of LLP in a call for proposals; this year have been identified the following general priorities:

Develop strategies for lifelong learning and mobility.

Objective: to encourage initiatives to develop mobility strategies and to remove obstacles to mobility. In this context, initiatives between regions from different Member States will be particularly encouraged. Mobility strategies, however, could also be developed at sectoral level (e.g. an industrial branch) or between educational institutions. The shift towards learning outcomes, effective lifelong guidance, the implementation of such tools as European Qualifications Framework (EQF) and National Qualifications Frameworks (NQFs), Europass, learning outcomes-based European Credit Transfer System (ECTS) and European Credit System for Vocational Education and Training (ECVET) that enhance lifelong learning and mobility, and promote the validation and recognition of non-formal and informal learning should also be further explored and developed.

Encourage cooperation between the worlds of education, training and work.

Objective: to encourage cooperation between all sectors of education, training and the world of work.

Support initial and continuous training of teachers, trainers and education and training institutions' managers.

competitiveness and prevention at Objective: to improve the quality of education and teachers and those who manage the education institutions.

> Promote the acquisition of key competences throughout the education and training system.

> Objective: to develop projects focused on some key competences (foreign languages, mathematical competence and basic competences in science and technology, digital competence, social and civic competences, sense of initiative and entrepreneurship, cultural awareness and expression).

> Promote social inclusion and gender equality in education and training, including the integration of migrants and Roma.

> Objective: reduction of early school leaving; promote social inclusion through education. Issues relating to the participation of migrants, groups with fewer opportunities, including Roma, and vulnerable social groups of people with special needs will be particularly important for schools, VET and adult education.

Promoting access to learning opportunities (including e-learning opportunities) for people with disabilities is a strategic priority applying to the programme as a whole.

These overall strategic priorities are reflected in various ways under the different subprogrammes supported by the LLP. Where necessary, additional – more specific – priorities are also identified per sub-programme or key activity. Every year a general call for proposals is published concerning all sectors covered by LLP under the following sub-programmes:

- Comenius Programme School education focuses on the first phase of a) education, from pre-school and primary to secondary schools. It is relevant for all members of the education community: pupils, teachers, local authorities, parents' associations, non-government organisations, teacher training institutes, universities and all other educational staff;
- b) Erasmus Programme Higher Education is the EU's education and training "Course on the tools and programme for mobility and cooperation in higher education across Europe. Its different actions not only address students wishing to study and work abroad, managing projects in the health but also higher education teachers and enterprise staff intending to teach context - MI Project"- second abroad and to higher education staff seeking training abroad. In addition, Erasmus supports higher education institutions to work together through intensive programmes, networks and multilateral projects as well as to reach out to the world of business;
- 15-16 -17-18 May 2012 Milan c) Leonardo da Vinci Programme links policy to practice in the field of vocational education and training (VET). Projects range from those giving individuals the chance to improve their competences, knowledge and skills through a period abroad, to Europe-wide co-operation between VET stakeholders in order to enhance the attractiveness, quality and performance of VET systems and practices;
 - d) Grundtvig Programme addresses the teaching and learning needs relating to all forms of adult learning which are not of a predominantly vocational nature, as well as the institutions and organisations providing or facilitating any form of such learning opportunities for adults - whether of a formal, non-formal or informal nature - including those involved in the initial and in-service training of staff;
 - e) Transversal Programme targeted on cross-sectoral areas (policy cooperation and innovation in lifelong learning, languages, development of innovative ICT, dissemination and exploitation of results);
- f) Jean Monnet action stimulates teaching, research and reflection on European Infoday: Europe and support to integration at higher education institutions throughout the world. With projects and across the five continents, the programme reaches up to 250 000 students every year.

Multilateral projects and networks under Comenius, Erasmus, Leonardo da Vinci, Grundtvig and the key activities of the Transversal programme are also open to partners from *third countries* which do not already participate in the Lifelong Learning Programme.

Who can participate: pupils, students, trainees and adult learners, teachers and other staff involved in any aspect of lifelong learning (LLL), people in the labour market, institutions or organisations providing learning opportunities in any area of education or training, persons and bodies responsible for systems and policies concerning any specific aspect of LLL at local, regional and national level, Enterprises, social partners and their organisations at all levels, including trade organisations, professional organisations and chambers of commerce and industry, bodies providing guidance, counselling and information services relating to any aspect of LLL, Associations working in the field of LLL, research centres and bodies concerned with education and training issues, not-for-profit organisations, voluntary bodies, non-governmental organisations (NGOs).

FET "Future and Emerging Technologies"

The FET scheme continues to act as the pathfinder for mainstream ICT research. It will lay new foundations for future ICT by exploring **unconventional ideas** that can <u>challenge our understanding</u> of the scientific concepts behind ICT and that can impact future industrial ICT research agendas.

Hence, its priorities are influenced by new developments and emerging opportunities in a wide range of scientific areas (health sector included), as well as by the need to nurture the emergence of novel, often multidisciplinary, European research communities. FET will operate with a **Proactive and an Open scheme**, including activities to support new talents and high-tech SMEs.

Objective of the call

This objective supports the exploration of **new and alternative ideas** that, because of their risky or non-conventional nature, would not be supported elsewhere in the ICT. It seeks:

- foundational breakthroughs as crucial steps towards radically new forms and uses of information and information technologies within a clear longterm vision that is far beyond the state of the art;
- demonstration activities, designed to prove the viability of new technologies that offer a potential economic advantage, but which cannot be commercialised directly (e.g. testing of product-like prototypes);

- ambitious proof-of-concept and its supporting scientific foundation, where novelty comes from new, high-risk ideas rather than from the refinement of current ICT approaches;
- new inter-disciplinary collaborations, possibly with prominent and internationally recognized non-EU research teams where these can provide a significant added value.

Funding scheme:

• Collaborative Projects CP (only Small and medium-scale focused research projects **STREP**).

Small and medium-scale focused research projects (STREP) are objective-driven research projects, which aim at generating new knowledge, including new technology, or common resources for research in order to improve European competitiveness, or to address major societal needs. They have clearly defined scientific and technological objectives directed at obtaining specific results, which could be applicable in terms of development or improvement of products, processes, services or policy.

Partnership: at least **3 independent legal entities**, each of which is established in a EU Member State (MS) or Associated Country (AC);

Duration: from 18 months up to 3 years (however, there is no formal minimum or maximum duration).

<u>Who can participate</u>: research institutes, private and public bodies, universities, Industries (including SMEs), International organizations, legal entities, potential end-users.

Challenge 5: ICT for Health, Ageing Well, Inclusion and Governance

The focus of Challenge 5 will be on development of solutions that empower the individual, in a social context, to improve and manage personal life as a citizen, elderly, patient, consumer, civil servant or worker.

Funding schemes:

- Small or medium-scale focused research projects (STREP)
 - Partnership: at least three legal entities established in different EU
 Member States or Associated countries;
 - Duration: STREPs are expected to last typically eighteen months to three years. However, there is no formal minimum or maximum duration.

 - Partnership: at least three legal entities established in different EU
 Member States or Associated countries;
 - Duration: IPs are expected to last typically three to five years. However, there is no formal minimum or maximum duration.

 - Partnership: at least three legal entities established in different EU
 Member States or Associated countries;
 - Duration: CAs are expected to last typically eighteen months to three years. However, there is no formal minimum or maximum duration.

 Marie Curie International Research Staff Exchange Scheme (IRSES) FP7-PEOPLE-2013-IRSES

<u>Deadline</u> for submitting proposals: **17 January 2013**

Indicative budget: **30** M€The Marie Curie International Research Staff Exchange Scheme is an action that aims to strengthen research partnerships through staff exchanges and networking activities between European research organisations and research organisations from countries with which the European Union has an S&T agreement or is in the process of negotiating one, and countries covered by the European Neighbourhood policy.

This action will provide support to research organisations to establish or reinforce long-term research cooperation through a coordinated joint programme of exchange of researchers for short periods.

<u>Funding scheme</u>: *Support for training and career development of researchers*.

Financial support will be provided for a period of 24 to 48 months, to <u>joint programmes</u> aiming at trans-national mobility of researchers, technical and management staff. For organisations in Member States and associated countries, the mobility shall be towards the other third country partners, and vice-versa.

Duration of exchanges: maximum 12 months

<u>Partnership</u>: at least two independent research organisations established in at least two different Member States or associated countries, and one or more research organisations either located in countries with which the European Union has or is in the process of negotiating an S&T agreement, or in countries covered by the European Neighbourhood Policy.

FP7-PEOPLE-2013-CIG _MARIE CURIE ACTION: CAREER INTEGRATION GRANTS (CIG)

Deadline for submitting proposals: 7 March and 18 September 2013

Indicative total budget: 40 M€

<u>Objective</u>: to strenghten the *European Research Area (ERA)* by encouraging researchers to establish themselves in a Member State or in an associated country, thereby attracting and retaining the best talents in Europe. The action is designed to support researchers in the first steps of their European research career and to attain lasting professional integration in the ERA. This action should also allow the transfer of knowledge that the researchers have acquired prior to the Career Integration Grant, as well as to the development of lasting cooperation with the scientific and/or industrial environment of the country from which they have moved.

<u>Who may apply?</u>: this action addresses researchers of any nationality who, at the relevant deadline for submission of proposals, correspond to the definition of *experienced researchers*, and who comply with the mobility rule. A researcher who has benefited or is benefiting from a reintegration or career integration grant (including IRG and ERG grants under both FP6 and FP7) <u>is ineligible</u> for funding under this call. The application is made jointly by a researcher and a host organization located in a Member State or an associated country.

<u>Funding scheme</u>: Support for training and career development of researchers.

The grant can cover a period of up to **4 years** (It corresponds to a flat rate contribution of $25\ 000\ \in$ per researcher and per year for the benefit of the recruited researcher, to contribute to his/her research costs at the career integration host).

• Call for proposals for Social Policy Experimentations (VP/2012/007)

Deadline: 15 February 2013.

This call for proposals on *social policy experimentations* intends to improve the quality and effectiveness of social policies and to facilitate their adaptation to new social needs and societal challenges. Through this call, PROGRESS countries embarking on welfare reforms are offered financial support to experiment envisaged policy changes and reforms before implementing them, if successful, on a wider scale. Selected projects have to contribute to developing and testing socially innovative approaches to policy priorities in the context of the Europe

MATTONE

2020 Strategy and the Open Method of Coordination on social protection and social inclusion. Projects should focus on a relevant issue within the context of employment and social policies. The Commission invites potential applicants to consider in particular the following themes:

- Promotion of youth activation measures to tackle and prevent youth unemployment and exclusion, in particular for young people facing multiple barriers to labour market entry (e.g. those living in rural, deprived urban, remote and peripheral areas);
- provision of quality childcare services;
- promotion of active and healthy ageing, which is underpinned by crosssectoral actions aiming, among others, at improving the health status and the quality of life, supporting the sustainability and efficiency of health care and social services systems, ensuring decent working conditions and prolonging working lives, as well as at promoting social inclusion and independent living for all citizens, with a particular focus on older people.

This call offers to applicants the possibility to develop social policy experiments according to the following two dimensions:

- Design of a potentially relevant policy intervention (with the description of the target group, of the social needs addressed and of the set of actions envisaged);
- design of the evaluation method (the evaluation protocol should be set up from the start of the project, in order to arrive at shared conclusions about the up-scaling potential of the tested policies, based on their measured impact).

As this call focuses on public policy interventions, it is addressed to public authorities acting as policy-makers, at national, regional or local level or to bodies governed by public law established in one of the PROGRESS participating countries. The participation to the call is also open to other stakeholders as: NGOs, social partners, social service providers and civil society organisations.

Partnership: at least 3 partners of 3 Progress participating countries (1 applicant + 2 partners).

The overall indicative amount made available for this call is 4 200 000 €. The grant requested should be 700 000 € minimum and 1 000 000 € maximum (1 000 000 € will be allocated to projects focusing on youth activation measures). The EU grant will not exceed 80% of the total eligible costs of the action.

Duration: between 24 months and 36 months.

Subject of the contract: to provide support services to the Commission for the development of social policy experimentation in the European Union, as a tool to test social and employment policy innovations and reforms before implementing them. Support services on social policy experimentation will help the European Commission to accompany Member States' efforts to innovate and modernise social policy, by providing the best European expertise in terms of the methods to design, implement and evaluate social policy experimentation. It will contribute to awareness raising and capacity building of organisations and administrations involved in the design, implementation and evaluation of social and employment policies, mainly through the organisation of trainings, information sessions and the production of communication tools. Furthermore, tailor-made advice will allow policy-makers willing to experiment to access the adequate support.

The contractor will be in charge of the development of the <u>following activities</u>:

- Creation of a community of stakeholders, supported by dedicated web content:
- production of communication and training tools for the community;
- provision of tailor-made advice on social policy experimentation, at the request of the Commission.

Budget: the maximum contract price, possible renewals included, is € 1.350.000 with a maximum annual budget of € 450.000. It may be renewed 2 times.

The topics of call 6 of the AAL JP: "ICT based solutions for Supporting Occupation in Life of Older Adults" have been discussed on 26 September 2012 during the AAL Forum 2012 in Eindhoven.

In many cases, the active older adult is still confronted with a "deficit model of age" that — often unsubstantiated - assumes that occupational efficiency and general learning ability decline with age and implies that older people are less innovative, less productive and less able to work under pressure than their younger colleagues. Empirical evidence suggests that the biggest challenges for older workers are indeed physical strain, mental stress and smaller age-related limitations. This is accompanied by increased skills and competence based on work experience and changing values and attitudes towards work and career. Developments in technical and organisational means to retain the knowledge, expertise and abilities of older workers in the workforce — on a paid or voluntary basis — will help to lessen any potentially detrimental effects of demographic ageing on economic development.

Call 6 of the AAL JP aims at funding the **development of ICT-based solutions** which enable older adults to continue managing their occupation – at work in an office or a factory (or any working environment), in a first or subsequent new second or third careers, in paid or voluntary occupation – while preserving health and motivation to remain active. The call shall target the preservation of cognitive and physical capabilities of older persons when performing their paid or unpaid activity.

It is anticipated that the call will be launched **end of January 2013**, with a proposal submission deadline end April 2013.

OUTCOME OF THE TRAINING COURSE "CAPACITY BUILDING: NEW SKILLS FOR REGIONAL HEALTH SYSTEMS TO PLAN IN EUROPE"

The Marche Region has recently hosted a training course specifically focussed on improving competences of local health system personnel in project management. The course was held in Ancona on five days in November 201, and has been jointly organised by the Marche Region, the Regional Health Agency and the Italian National Institute of Science on Health and Aging (INRCA) in the framework of action 2A of the Mattone Internazionale project.

The reasons to host the training course came on the one hand by the need , for the local health systems to face the fact that social and macro-economic changes have occurred all over Europe .

On the other hand, research and innovation in the health sector will be likely to be increasingly depend on European funds, since public national expenditure is being cut as a consequence of the recent financial crisis: the most urgent priority for professional engaged in the health system is to attract these resources and invest them in improving services to citizens.

Different topics have been discussed during the five days, all of them mainly about how to write and manage European projects, policies concerning research and innovation, techniques of project management, networking and creation of the consortium, and economical and financial aspects.

In this sense, the course provided methodological tools and contents for increasing participants' competences in project management, to be potentially applied in different contexts, especially within the main Programmes considered as priorities in the Mattone Internazionale project (Horizon 2020, European Programme for Research, National Plan for Prevention etc.).

Training was structured through the alternation of two complementary approaches. The first one – which emphasised theoretical and methodological aspects – included both presentations and discussions on above mentioned themes, as well as the explanation of good practices, by organisers and each one of the 13 external experts involved. The second approach – which stressed practical aspects – was dedicated to specific project works: the 25 participants have been grouped in work teams which wrote a draft proposal for a real call, with the support of experts and tutors.

The course has been realized tank to the participation of professionals from different fields: private for- (consultants and expert in European projects) and no -profit sector (publicly-owned companies), Local Health Authorities, the IRCCS-INRCA and the regional universities. The participation of highly qualified speakers from foreign institutions, such as Juliet Craig (Università Sheffield) and Alice Sinigaglia (representative of the pan-european association, AGE PLATFORM) ensured a wider international breath to the event.

OUTCOME OF WORKSHOP "EU-WIDW STRATEGIES FOR ALCOHOL PREVENTION".

Alcohol is one of the world's top three priority of public health. On 13 and 14 December was held in Venice, at the offices of Veneto Region, the workshop: "EU-wide strategies for alcohol prevention".

The event, organized in the framework of the activities implemented by the project Mattone Internazionale, was aimed at sharing information for the identification and dissemination of best practices and most effective strategies for the prevention, treatment and reduction of the social and health impact of alcohol abuse among young people and the elderly. *Mr. Paolo Stocco*, Gen. Dir. LHA n.10 Veneto Orientale, opened the meeting, while the two-days sessions were coordinated by three experts from Spain who are working on issues related to alcohol and addictions: *Mr. Amador Calafat* (Psychiatrist and Psychologist, European Institute for the Study of Prevention IREFREA), *Mr. Elisardo Becoña* (Prof. of Clinical Psychology, University of Santiago de Compostela) and *Mr. Joan Ramon Villalbi* (Deputy Gen. Dir Agencia de Salut Pública de Barcelona).

During the event there have been important speeches by *Mr. Francesco Zambon* (WHO Regional Office for Europe, Venice), who outlined the priorities of the *European Action Plan to reduce the harmful use of alcohol 2012-2020, Mr. Georgios Margetidis* (Executive Agency for Health and Consumers EAHC), who gave the point of view of the EU Commission on strategies to reduce alcohol-related harm in Europe, *Mr. Mauro Cibin* (Dir. Public Service for drug and alcohol addiction, LHA n.13 Mirano) who emphasized the role of alcohol as a common element of poly-abuse and addictive behaviors and, finally, *Ms. Michela Frezza* (Veneto Region) who described the "*Project Addictions 2012/2014*".

At the end of the second day have been organized working group sessions with the active involvement of the participants.

NEW INVITATION FOR COMMITMENT ON ACTIVE AND HEALTHY AGEING

Within the end of December 2012 the European Commission will launch the second "Invitation for Commitment" on Active and Healthy Ageing. The deadline for commitments presentation is foreseen by the end of January 2013.

The application procedure will be similar to the one used in the past. The Commission will make a first selection and will consult the action groups in order to assign new committments to existing action groups or to create new actions. Beneficiaries will be health operators, local, national and regional authorities, NGOs, universities etc...

A DIGITAL FUTURE FOR HEALTHCARE: THE NEW EHEALTH ACTION PLAN

The European Commission has unveiled an Action Plan to address barriers to the full use of digital solutions in Europe's healthcare systems. The European Commission's eHealth Action Plan 2012 – 2020 provides a roadmap to empower patients and healthcare workers, link up devices and technologies, and invest in research towards the personalised medicine of the future. This means providing smarter, safer and patient-centred health services.

The four pillars and objectives of the eHealth Action Plan are the following (1) Achieve wider interoperability in eHealth services (2) Support research and innovation and competitiveness in eHealth (3) Facilitate deployment and adoption of eHealth and (4) Promote international cooperation on eHealth at global level. The ultimate goal is to improve healthcare for the benefit of patients, give patients more control of their care and bring down costs. While patients and health professionals are enthusiastically using telehealth solutions and millions of Europeans have downloaded smartphone apps to keep track of their health and wellbeing, digital healthcare has yet to reap its great potential to improve healthcare and generate efficiency savings. Given the fast growing uptake of smartphones and tablets, the action plan also includes a specific focus on mobile health (mHealth). In specific, the Action Plan will attempt to increase the pace of change and improvement in healthcare by enhancing user confidence in digital tools and apps, while at the same time ensuring that the market conditions encourage continued innovation. As a result, healthcare workers will have the opportunity to develop and enhance their digital skills thus, increasing their confidence in working with digital health tools, doctors will have more meaningful time with their patients and less unnecessary appointments, while patients will spend less time, effort and money on unnecessary hospital or GP visits.

This action plan builds on a series of pioneering initiatives that are now beginning to bear fruit such as the epSOS pilot where 23 countries are working together to achieve cross-border interoperability between electronic health record systems in Europe. Thanks to epSOS, tourists, business travellers, commuters or exchange students will be able to enjoy seamless access to high quality and safe healthcare abroad.

Renewing Health has allowed nine leading regions to pool their efforts to revolutionise the management of chronic diseases. Diabetics and heart patients, among others, can manage their own diseases from the comfort of their own homes and take an active role in improving their conditions while achieving better health outcomes. Health-e-Child is another example of a collaborative platform. This growing network allows paediatricians across Europe to pull together essential clinical information relating to heart diseases, inflammatory diseases, and brain tumours meaning that in the future, more children suffering from these diseases will be able to benefit from early diagnosis, screening, individualised disease prevention and therapy.

TONE NEWS

Both Neelie Kroes, Commission Vice President for the Digital Agenda and Tonio Borg, Commissioner for Health and Consumer Policy have publically supported and welcomed the new ehealth Action Plan. During a recent speech Neelie Kroes said "Europe's healthcare systems aren't yet broken, but the cracks are beginning to show. It's time to give this 20th Century model a health check. The new European eHealth Action Plan sets out how we can bring digital benefits to healthcare, and lift the barriers to smarter, safer, patient-centred health services."

The paper clarifies the issues a healthcare practitioner faces in delivering cross-border telemedicine. In this regards, members of the new eHealth Network, established by the Cross-border Healthcare Directive will help implement the Action Plan and provide a direct link to the national healthcare authorities and government departments.
